



## Energy surcharge for domestic parcel services

The average prices of diesel, petrol and electricity in 2021 as per the National Consumer Price Index (CPI) are the basis of the price index (=100%). The new average prices as per the National CPI are fixed each month and used to calculate the price index vis-à-vis the base. The resulting price index that is calculated is then multiplied by the "Energy mix for the vehicle operations for parcel and letter delivery in the Logistics Services unit". This results in the total energy cost index (marked in blue), which determines the surcharge that is valid at the present time.
